The Board discussed the Administrative Directors proposal to begin conversations with IDA Park tenants and Lockport Energy Associates to consider if or how power might be brought into the IDA Park directly from the energy plant to cover current and future needs of the IDA Park. The Board felt that this would be a worth while effort to improve the future of the IDA Park and tenants.

**ATTORNEYS REPORT;** The IDA Attorney discussed the transfer of ownership between Lacey Heavy Equipment and Ayers Holding, Inc.

Motion to authorize the release of 6221 Dysinger, Inc. and its principal from contractual obligations pursuant to the lease/leaseback and closing documents dated as of September 1, 2016, upon closing of its asset/transfer to Ayers Holding, Inc. and/or TDA LLC, together with receipt and approval of assignment of lease/leaseback and execution of agreement by the assigning entity and assumption of all obligations of the lease/leaseback and related documents, and to consent to such assignment, subject to approval of the above by the Lockport IDA Attorney, and to authorize any officer, director, or the Administrative Director of the IDA to execute all necessary closing documents, including the associated mortgage together with authorization for mortgage tax exemption.
